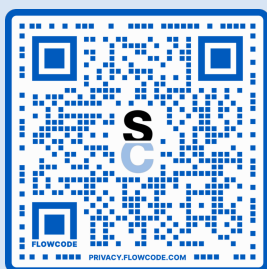
WHAT DOES A WORKERS' COMP LAWYER DO ?
