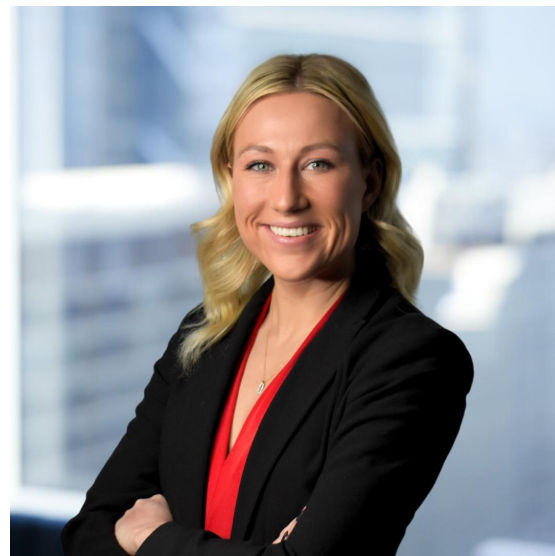

How Long Does Workers' Comp Litigation Take?

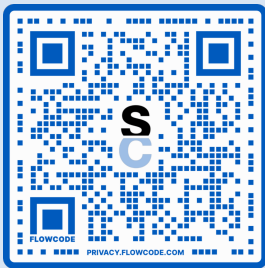
